1. In accordance with DA PAM 385-10, request the U.S. Army Safety Excellence Streamer be awarded to the U.S. Army Garrison, Fort McCoy.
2. The Fort McCoy Garrison has met the regulation requirements for obtaining this award. The Fort McCoy Garrison has not experienced a Class A or Class B accident in over 112 months (July 2006 - October 2015); The Command conducted an Army Readiness Assessment Program (ARAP) in FY14; and Risk Management is continually emphasized throughout the Garrison by Commanders, Leaders, the Installation Safety Office (ISO), and the Directorate of Human Resources through orientation and required training. The Fort McCoy Garrison is proud of its safety accomplishments and looks forward to displaying the U.S. Army Safety Excellence Streamer on the USAG, Fort McCoy guidon.
3. Significant achievements of the Fort McCoy Garrison:
 - a. Over 112 consecutive months without experiencing a Class A or Class B accident.
 - b. The Fort McCoy Garrison has achieved 100% completion of CRM training for USAG Soldiers and DA Civilian employees through orientation training, on-line access, and class room training conducted by the ISO.
 - c. Completed ARAP on 14 April 2014. Out briefed Garrison Commander and implemented action plans to address weaknesses.
 - d. Conducted annual installation level Safety Day events over the past nine years. Events included the involvement of Soldiers, Family members, DA Civilians and government contractors.
