AMPN// (U) REFERENCE PROVIDES THE REQUIREMENT FOR ENROLLMENT INTO THE ARMY READINESS ASSESSMENT PROGRAM (ARAP)//

1. (U/FOUO) SITUATION. IN THE SEPTEMBER 2018 ANALYSIS OF UNIT ARMY READINESS ASSESSMENT PROGRAM (ARAP) ENROLLMENT, THE DIRECTOR OF ARMY SAFETY IDENTIFIED A LOW COMPLIANCE RATE AT/OR BELOW 40%. THIS EXORD RE-EMPHASIZES THE REQUIREMENT OF ALL ACTIVE DUTY BATTALION AND BATTALION-EQUIVALENT UNITS TO ENROLL IN ARAP WITHIN NINETY (90) DAYS OF A NEW COMMANDER ASSUMING COMMAND; AND ARMY RESERVE AND ARMY NATIONAL GUARD BATTALION AND BATTALION-EQUIVALENT UNITS TO ENROLL IN ARAP WITHIN ONE HUNDRED AND TWENTY (120) DAYS OF A NEW COMMANDER ASSUMING COMMAND.

- 2. (U/FOUO) MISSION. EFFECTIVE IMMEDIATELY, COMMANDERS, ARMY COMMANDS (ACOMS), ARMY SERVICE COMPONENT COMMANDS (ASCCS), AND DIRECT REPORTING UNITS (DRUS) WILL VERIFY COMPLIANCE AND EXECUTION OF ENROLLMENT OF ALL ACTIVE DUTY BATTALION AND BATTALION-EQUIVALENT ORGANIZATIONS INTO ARAP WITHIN NINETY (90) DAYS; AND ARMY RESERVE AND ARMY NATIONAL GUARD BATTALION AND BATTALION-EQUIVALENT UNITS TO ENROLL INTO ARAP WITHIN ONE HUNDRED AND TWENTY (120) DAYS OF A NEW COMMANDER ASSUMING COMMAND.

- 3.A. INTENT. INCREASE OVERALL AWARENESS OF THE ARMY SAFETY CULTURE WHILE PROVIDING METRICS TO COMMANDERS TO REDUCE MISHAPS AND IMPROVE RISK MITIGATION PROCEDURES.
- 3.B. TASKS TO SUBORDINATE UNITS.
- 3.B.1. COMMANDERS, ARMY COMMANDS (ACOM), ARMY SERVICE COMPONENT COMMANDS (ASCC), AND DIRECT REPORTING UNITS (DRU).
- 3.B.1.A. REVIEW ARAP ENROLLMENT OF ALL SUBORDINATE BATTALION AND BATTALION-EQUIVALENT UNITS AND ENSURE COMPLIANCE WITHIN NINETY (90) DAYS FOR ACTIVE DUTY UNITS AND ONE HUNDRED AND TWENTY (120) DAYS FOR RESERVE COMPONENT UNITS (ARMY RESERVE AND ARMY NATIONAL GUARD) OF A NEW COMMANDER ASSUMING COMMAND.
- 3.B.1.B. VALIDATE ALL UNIT IDENTIFICATION CODES (UIC) TO VERIFY THEY ARE CURRENT AND CORRECT WITHIN THE ARAP SYSTEM. THE RESPECTIVE ACOM, ASCC OR DRU HEADQUARTERS SAFETY OFFICES WILL NOTIFY THE U.S. ARMY COMBAT READINESS CENTER (USACRC) OF UIC DISCREPANCIES TO ENSURE PROPER REPORTING.
- 3.B.1.C. ORGANIZATIONS WILL VERIFY ENROLLMENT WITH THE ARAP TEAM AT USACRC AS NECESSARY.
- 3.B.2. HQDA, DIRECTOR OF ARMY SAFETY (DASAF) AND COMMANDER, USACRC. BRIEF COMPLIANCE STATISTICS TO THE SECRETARY OF THE ARMY (SECARMY) AND CHIEF OF STAFF OF THE ARMY (CSA) DURING MONTHLY PRIORITY READINESS REVIEWS BEGINNING ON 07 JANUARY 2019, UNTIL NO LONGER REQUIRED.
- 3.C. COORDINATING INSTRUCTIONS.
- 3.C.1. DIRECT COORDINATION IS AUTHORIZED (DIRLAUTH) FOR ALL ARMY ORGANIZATIONS.
- 3.C.2. ACOMS, ASCCS, DRUS, AND USACRC ARAP TEAM WILL WORK TOGETHER TO CORRECT ANY DISCREPANCIES IDENTIFIED DURING THE UIC VALIDATION AND ENROLLMENT PROCESS.
